92.5 KJJY'S "PUMPKIN RANCH ONLINE" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station KJJY ("Station"), 4143 109th Street, Urbandale, Iowa 50322, during available business hours Monday through Friday, on the Station website www.kjjy.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **92.5 KJJY's "PUMPKIN RANCH ONLINE"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility.  - c. 12:00 AM CT on October 1, 2022 and will run through 11:59 PM CT on October 7, 2022 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
 - **d.** 12:00 AM CT on October 8, 2022 and will run through 11:59 PM CT on October 14, 2022 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.

3. How to Enter.

Online: Visit the Station's website www.kjjy.com during the Contest Period, click on the "Contest" link, click on the "Pumpkin Ranch Online" Contest link, and complete an entry form. All entries must be received by 11:59 PM CT on the last date of each contest period to be eligible for a chance to win a prize. Limit one (1) entry per person per day, regardless of how many email addresses a person may possess and use. Multiple entrants are not permitted to share the same email address. - **4. Winner Selection.** On or about 9:00 AM CT the following Monday of each contest period, the Station will select One (1) potential winner(s) in a random drawing from among all valid entries received by Station during the Contest Period. Each winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules).
